## UNHEARD VOICES OF KAFALA: SEEKING HEALTHCARE UNDER THE KAFALA SYSTEM



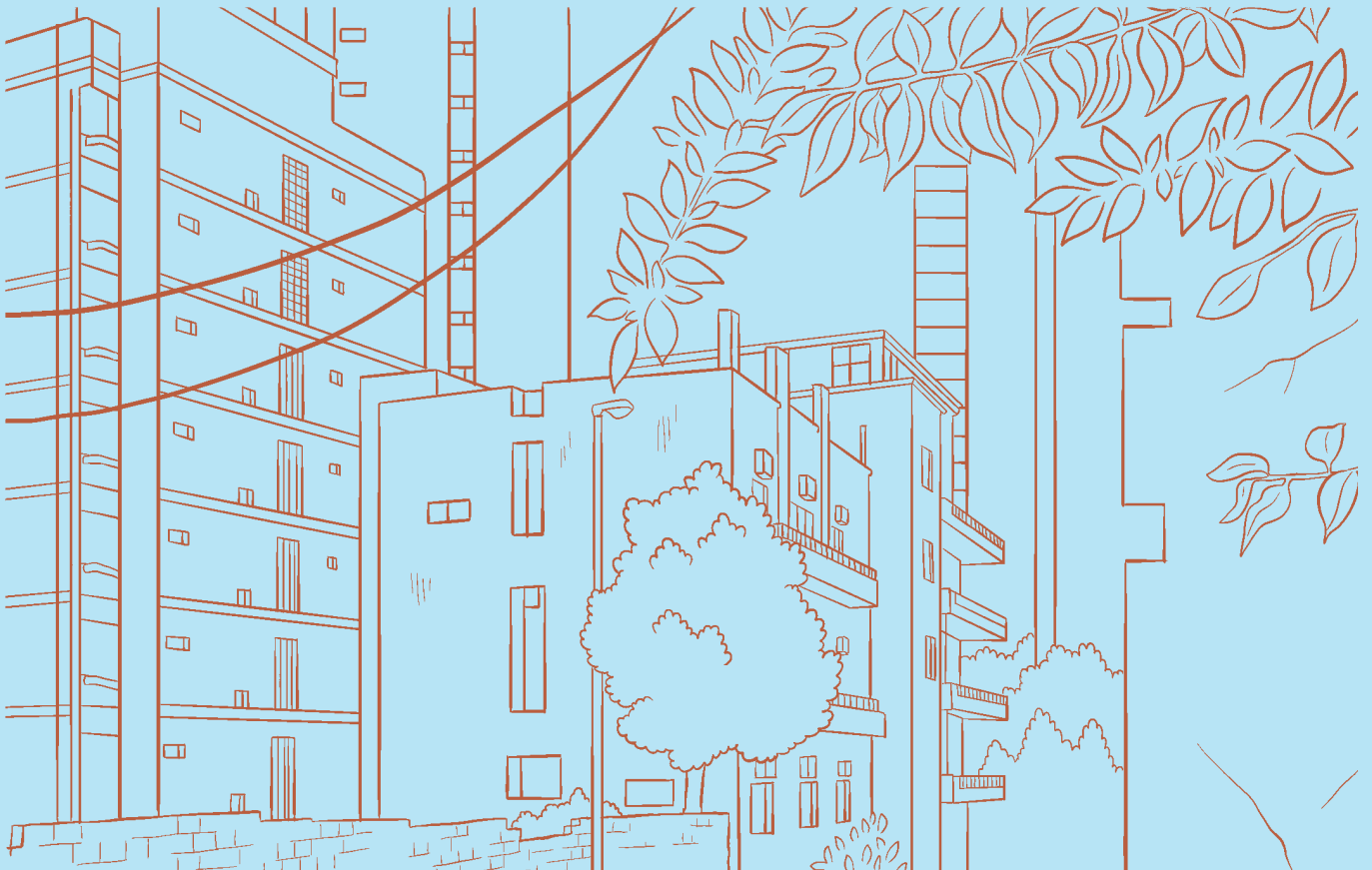

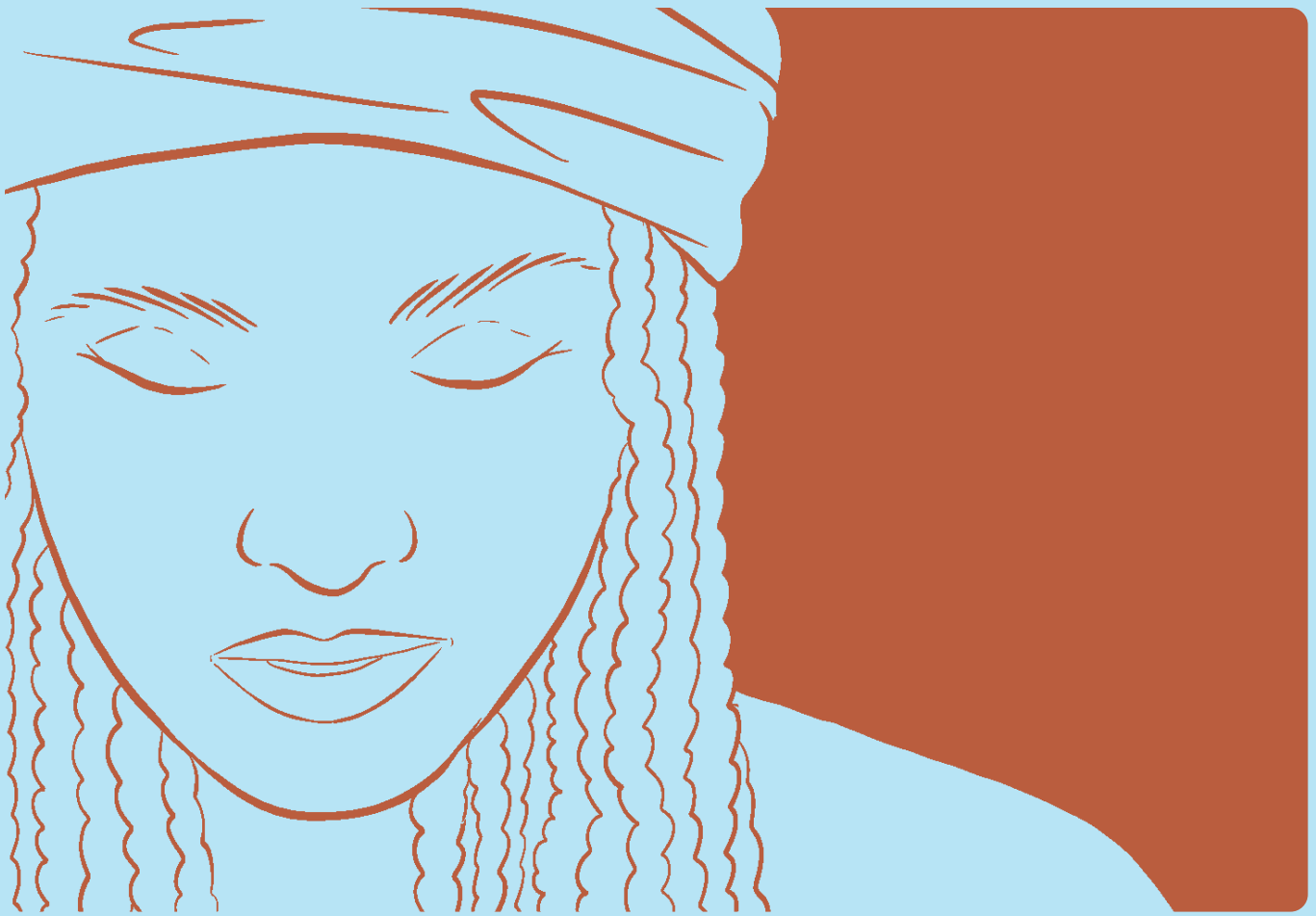
# INTRODUCTION

In 2020, Médecins Sans Frontières/Doctors Without Borders (MSF) opened a clinic in the Lebanese capital, Beirut, providing general health consultations and specialist mental health support, free of charge, to migrant workers.

In these consultations, our patients – most of them women – have described to our staff the poor living and working conditions experienced by them under the Kafala system. This system is currently the only legal option for migrants to work in Lebanon since they are excluded from Lebanese Labour Law.

Despite the medical and mental health needs of migrant workers in Lebanon, they face multiple obstacles when trying to access health services, including discrimination, not having the right documents, a shortage of translators, the high cost of care, and gaps in health insurance coverage.





Their vulnerabilities were heightened by the COVID-19 pandemic and the ongoing economic crisis. With employers struggling to pay their salaries, many workers suddenly found themselves without a job. Some were simply dropped off in front of their embassies and left to fend for themselves.

The very nature of the Kafala system, which ties contracts to residency status, means that as soon as migrant workers lose their jobs, they are deemed to be living in Lebanon irregularly, making it even harder to access basic services. Most find themselves living in overcrowded or unsafe housing and many resort to harmful behaviours to cope.



It was in the context of the COVID-19 pandemic and the economic crisis that MSF was asked to provide urgent medical and mental health support to migrant workers. Some of them had severe mental health disorders due to the extremely precarious situation in which they suddenly found themselves.

Two years after MSF's clinic in Beirut first opened its doors, patients continue to describe the impact on their health and wellbeing of living and working conditions under the Kafala system. Our patients seek care for a range of medical conditions directly linked to the tasks they are required to perform, while restrictions on their movements and their lack of autonomy deeply impact their mental state.



In 2022, the UN estimates that 135,000 migrant workers reside in Lebanon, mostly in Beirut and Mount Lebanon governorates.

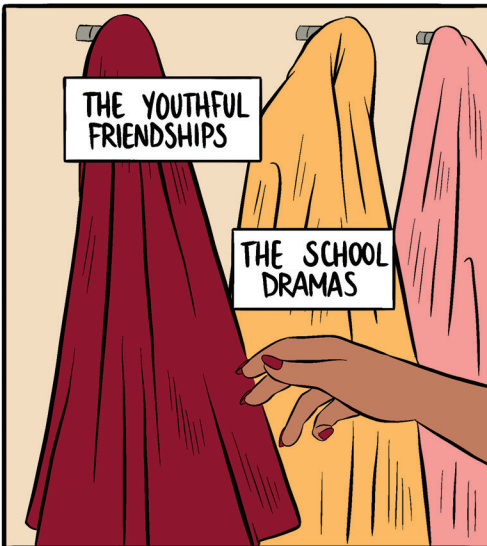
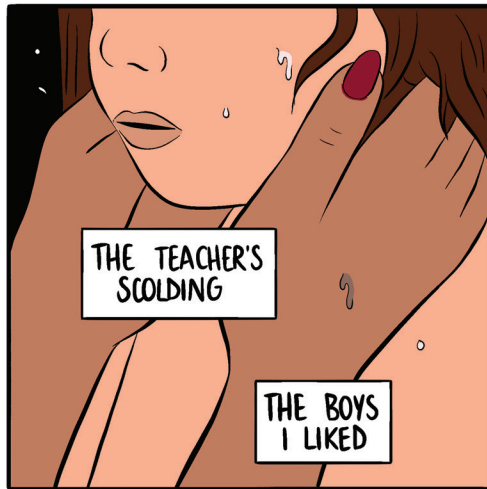
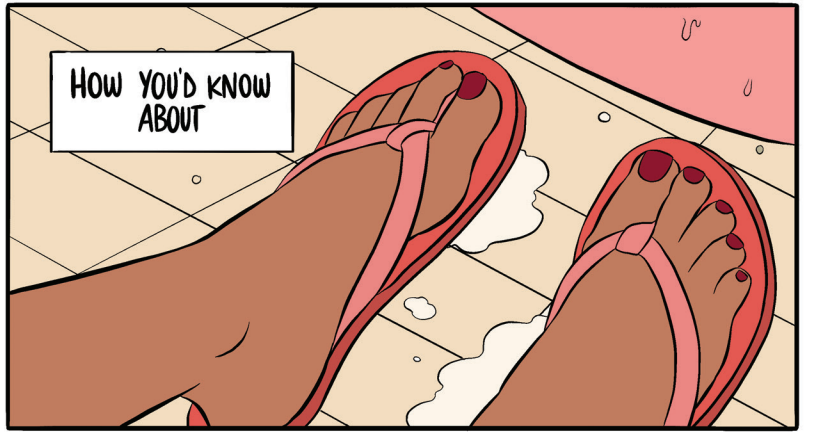
This graphic novel is based on interviews with MSF patients and staff who have been personally affected by the Kafala system. Their stories demonstrate how the current system creates physical and mental suffering for the migrant workers providing Lebanese families with much-needed services, including childcare and care of the elderly. Our teams can treat the symptoms of the Kafala system, but to see a tangible improvement in the health and wellbeing of migrant workers, the system needs to be reformed.

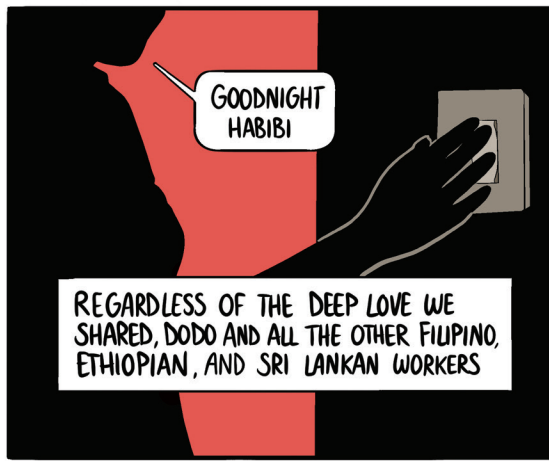

# THE KAFALA SYSTEM

MIGRANT WORKERS ARE EXCLUDED FROM LABOR LAW. CURRENTLY, THE KAFALA SYSTEM IS THE ONLY WAY TO GET HIRED AND WORK IN LEBANON



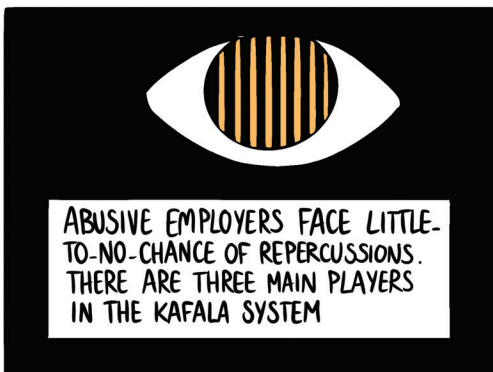
WITHOUT A "KAHEEL" OR SPONSOR, THEY ARE REGARDED AS ILLEGAL AND CAN FACE PROSECUTION.



EACH ONE NEEDS AN IN-COUNTRY SPONSOR, USUALLY THEIR EMPLOYER, WHO IS RESPONSIBLE FOR THEIR LEGAL STATUS

WORK CONTRACTS ARE EXTREMELY VAGUE AND CONTAIN A POWER IMBALANCE BETWEEN EMPLOYERS AND EMPLOYEES, MAKING IT EASY FOR EMPLOYERS TO EXPLOIT DOMESTIC WORKERS

THEY CAN'T LEAVE THE EMPLOYER OR END THEIR CONTRACTS, WITHOUT THE EMPLOYER'S APPROVAL, EXCEPT IN CASES OF SEVERE ABUSE WHICH IN PRACTICE ARE VERY HARD TO PROVE



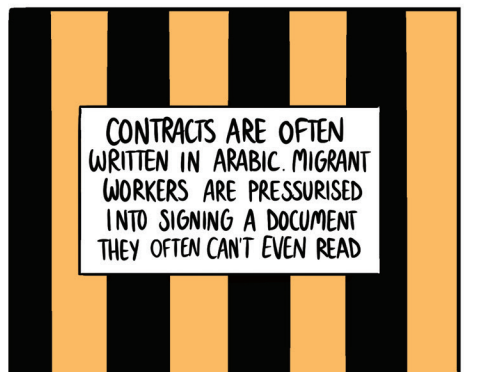

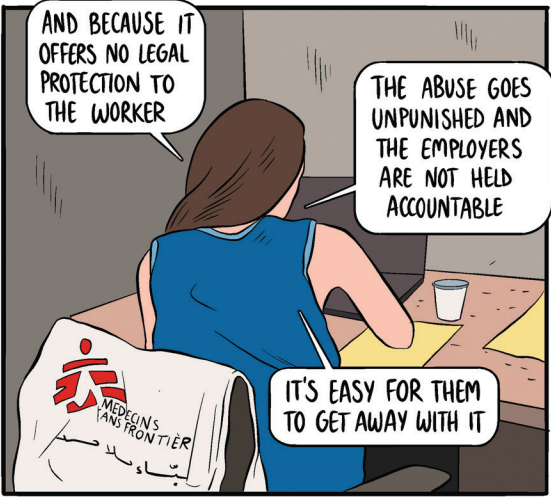
LARA IS A SOCIAL WORKER. SHE ASSESSES THE SITUATION OF PATIENTS
